The New Jersey Academy uses the ChildFirst training model, which includes 40 hours of instruction covering children development, memory, dynamics of disclosure, corroboration, sources of error in children’s testimony, and forensic interviewing. Training culminates in two days of practical exercises that synthesize concepts into evidence-based skill. The academy holds 6 trainings per year—3 trainings for municipal law enforcement agencies and 3 trainings for statewide multi-disciplinary teams (MDTs). Faculty members also facilitate peer review statewide to professionals who interview children.

EBI translates current psychological science into effective and defensible interviewing and investigative practices. EBI works with investigators to integrate these practices with their unique investigative needs and legal requirements. EBI conducts forensic interviews on a contractual basis in special case scenarios. EBI has trained a diverse range of investigative agencies, including the New Jersey

Office of Attorney General’s Clergy Abuse Task Force, the Michigan SAKI cold-case network, Texas Forensic Nurse Examiners, and the Baltimore Center for Hope (the metro-Baltimore children’s advocacy center).
